



# **Killington Stage Race**

## **Stage 1 Communiqué**

### **26 May 12**

#### **General Information:**

Due to an accident on the course, the final intermediate sprint was canceled for the Men Pro/1 & Men 3 fields.

Due to an accident on the course, the Men 4/5 finish was neutralized; all riders were classified equally. Final sprint points and time bonuses were not awarded.

The ITT start times have been modified based on field sizes. The start times no longer match the Tech Guide. Times are posted on-line, at the Mountain Green Resort and will be posted at the start of the ITT.

All Junior riders (racing in any category) are reminded that rollout is required for all events. Saturday's rollout is located at the finish.

#### **Penalties**

##### **Men Pro/1**

Riders 21 & 32 are penalized 30 seconds on GC crossing of the centerline to advance position. USAC 4H11d.

Rider 17 is penalized 60 seconds on GC for repeated crossing of the centerline USAC 4h11(d).

Rider 21 is fined \$35 US for ignoring the instructions of the moto referee. USAC 4H3.

##### **Men 2**

Rider # 250 is fined \$100 US for theft of food or drink. USAC 4H14c.

Rider 268 is penalized 30 seconds on GC for crossing the centerline to advance position. USAC 4H11d.

Rider #239 was relegated during the 2<sup>nd</sup> intermediate sprint for failing to maintain his line during the sprint. USAC 4H9.

Rider 622 is penalized 30 seconds on GC for advancing over the centerline. USAC 4H11d.

Rider 616 is fined \$ 35US for insults, threats, & rude behavior towards other competitors and officials. USAC 4H16a.

Rider 736 is penalized 60 seconds on GC for failing rollout. KSR Tech Guide.
